5. Types of Cookies We Use

5.1 Session Cookies

Session cookies are temporary cookies that are deleted when you close your browser

We use session cookies to:

5.2 Persistent Cookies

Persistent cookies remain on your device for a specified period or until manually deleted.

We use persistent cookies to:

- Recognize returning users
- Store user preferences and settings
- Analyze user behavior and improve website structure
- Deliver relevant content and advertisements
- Prevent repetitive survey participation
- Identify users for account-related activities such as login recognition, account preferences, and geographic identification

5.3 Third-Party Cookies

We may allow third-party service providers to place cookies on your device. These cookies are controlled by external parties and used for:

- Advertising and remarketing (e.g., Google Ads)
- Website analytics (e.g., Google Analytics)
- Tracking user interactions with ads
- Measuring campaign effectiveness
- Understanding website usage patterns

Persistent cookies remain on your device for a specified period or until manually deleted.

6. Data Collected Through Cookies

Cookies may collect information such as:

- IP address
- Device type and browser information
- Pages visited and time spent
- User interactions and navigation patterns
- Approximate geographic location

This data is generally aggregated and used for analytical and performance purposes.

7. Managing and Blocking Cookies

You have the right to control and manage cookies at any time.

You can:

- Delete cookies stored on your device

- Receive alerts when cookies are being used
